Kate Halischak, Immediate Past Faculty Senate President, will present for approval a proposed *Policy on the Avoidance of Conflict of Interest in Academic Matters*. The proposed new policy was developed with input from the Registrar, General Counsel and Faculty Senate Executive Committee. The linked policy was distributed to Senators on February 2, with a request to forward suggested verbiage revisions to the Faculty Senate by 5 PM on February 7 for consideration by the Faculty Senate Executive Committee on February 8. If the policy is revised, the final version of the policy will be distributed to Senators no later than the morning of the Senate meeting.
