Bylaws and Nominations Committee

Standing Rules

The Committee monitors the Bylaws of the Faculty Senate, reviewing proposals for changes and recommending amendments for action by the Senate. It serves in an advisory capacity to the Senate President and to the Executive Committee in all matters related to the Bylaws.

Each Fall, the Committee shall nominate candidates for Faculty Senate President-Elect, the Faculty Senate Executive Committee, and the Interinstitutuional Faculty Senate (IFS), in accordance with procedures described in the Bylaws.

In response to a call for nominations from the IFS, the committee shall be responsible for nominating members of the OSU faculty to serve on the Oregon State Board of Higher Education. The slate of nominees from OSU shall be endorsed by the Faculty Senate prior to forwarding to the IFS. The IFS oversees the process by which three Oregon University System faculty are nominated to the governor for the appointment.

The Committee consists of four Faculty members. One member shall be the Immediate Past Senate President, who shall serve as Chair.

The Future

The Committee did not act on a request from OSU-Cascades for a separate apportionment unit. The Committee did discuss the pros and cons of the request and decided not to take action at this time. Committee members were concerned about setting a possible precedent and believed that apportionment is adequately covered by the faculty member's academic home. The Provost of the Cascades Campus and the University Provost are both supportive of the request.

The committee reviewed the lack of policy on executive committee absences and suggested that three unexcused absences in a term warranted a warning from the President.

It is suggested that Committee members realize the difficulty in securing qualified candidates for positions, especially for President-elect. Recruitment should begin at the start of the academic year to secure a full slate of nominees.

1. Committee Members

2. Senate Elections

We had the opportunity to develop two slates of candidates in 2004-2005. In July 2004, President-Elect Mina McDaniel resigned to accept the position of OSU Director of Academic Programs and Academic Assessment. The Committee met and developed an initial slate. Jennifer Conner-Smith had kept good records from the prior yea's routine nomination process. We were able to ask a number of people who had declined previously, yet agreed to reconsider at a later date. Still, it was difficult to find candidates on short notice - to begin serving in January 2005. Jeff Hale and Mina Carson, agreed to run and Jeff was elected by mail vote.

In October 2004, we developed a complete slate of candidates for the offices and the Executive Committee. Our initial list of 15 candidates was well balanced with eight women and representation from most of the colleges. Vickie Nunnemaker verified eligibility and the Committee Members each took some of the potential candidates and asked them to run. Gaining commitments was difficult, as it has been in the past. The Executive Committee suggested a number of additional candidates, the Bylaws & Nominations Committee considered those recommendations and contacted some of those people. This raised an area of concern.

The Executive Committee expressed some frustration that the Bylaws & Nominations Committee exercised some autonomy and did not automatically contact the people suggested by the Executive Committee. If the Executive Committee's recommendations are to be accepted without evaluation, then the Bylaws need to be explicit on this point and the Executive Committee needs to develop a procedure to have a careful discussion about each potential candidate that approximates the types of discussions the Bylaws & Nominations Committee completes.

There may also be an expectation by some members of the Executive Committee, and presumably the Faculty Senate, that the Bylaws & Nominations Committee will keep pursuing a balanced slate in terms of gender and college representation until that balance is achieved. As the deadline for publication of the slate and approval by the Senate draws near, that becomes quite difficult. Either that expectation needs to be adjusted or the Executive Committee may want at some point to assume responsibility for the slate. That procedure would also require a Bylaws revision. Eventually Bill Boggess and Mike Quinn agreed to run for President-Elect and the rest of the slate was filled with 14 nominees - 8 men and 6 women from six colleges and the Associated Faculty.

3. Five-Year Review

In the Spring of 2005, the Bylaws & Nominations Committee worked with the Committee on Committees, specifically Darrell Ross who was a great help, on its five-year review. The response to the Committee on Committees, Sorte/Ross May 2, 2005 email, is attached and the recommendation was to continue the Bylaws & Nomination Committee. No major items were raised, however it was interesting

that we could not find a requirement in our standing rules to complete an annual report and believed that might be a good addition.

4. Bylaws Revisions

A number of revisions, per the Hale/Sorte memo of March 28, 2005 - attached, were proposed by the Executive Committee. The Bylaws & Nominations Committee agreed with most of the proposed changes. However, the Committee could not agree with providing more flexibility in terms of the number of Senate meetings per year - reducing the number of required meetings from nine to seven, per the Sorte/Nunnemaker email of May 2, 2005 - attached.

5. Future

The Executive and Bylaws & Nominations Committees' roles in developing the slate of candidates may need some clarification.

It may be worthwhile to visit on a confidential basis with potential candidates who declined to serve as an officer or Executive Committee member to determine what might have induced them to accept the nomination and run. Some small stipend may be useful to encourage participation by providing the necessary relief from teaching, research or public service duties to concentrate on issues that can be complex and have the opportunity to substantially affect the teaching, research and public service provided by OSU.

Thank you for the support provided and professional manner that issues were addressed by the Faculty Senate officers, Vickie Nunnemaker and the Executive Committee as we worked through some challenging circumstances to maintain good leadership and policies for the Senate.

- 2. Wayne Huber, Professor, Civil, Construction, and Environmental Engineering

III. Bylaws Revisions.

- A. The Committee asked Ken Williamson, Bylaws and Nominations Committee Past Chair, to make a presentation at the October, 2001 Senate Meeting. In his presentation he discussed a proposed Faculty Senate Bylaws revisions to add the senior IFS Senator to the Executive Committee. These revisions were presented for a vote at the November Senate meeting.
- B. The Committee brought two proposals for Bylaws revision to the June, 2002, Senate Meeting. One designated the new School of Education as an apportionment unit and the second specified that persons elected to IFS positions shall retain their Faculty Senate

seats for the remainder of their Senate terms.

IV. The Future.

- A. The Committee had no unfinished business at the end of its term.
- B. Next year's committee should be alert to apportionment consequences of university reorganization resulting from the OSU 2007 process.
- C. The difficulty of securing candidates for the President-elect position suggests the Committee should start recruiting very soon after the start of the academic year to guarantee a full slate of qualified nominees.

- 3. Proposed revisions to the Faculty Senate Bylaws. The Committee endorses a change in the Faculty Senate Bylaws to include the senior IFS representative as a member of the Executive Committee.

In Article VII, Section 1. we suggest adding after the Immediate Past President, ", and the senior IFS representative,".

In Article VIII, Section 2, we suggest adding at the end of the paragraph "The senior IFS Representative shall serve as an Ex-Officio member of the Executive Committee."

The following is a list of the activities of the Bylaws and Nominations Committee during the past year:

1. Nominated two candidates for Faculty Senate President-Elect, eight candidates for the Faculty

Senate Executive Committee (to fill three positions), and two candidates for the Interinstitutional

Faculty Senate. Two nominees were added from the floor for the Executive Committee. Henry

Sayre was elected President-elect, and Bruce Sorte was elected IFS

Representative. There was

a 35% return of ballots in the President-elect and IFS Representative elections. At the December

meeting of the Faculty Senate, Vicki Collins (Tolar Burton), Stella Coakley, and Rubin Landau

were elected to two-year terms on the Executive Committee.

2. Referred to the Executive Committee the issue of whether it is appropriate to maintain the

current off-campus Extension faculty to the Extension apportionment group or whether to propose

that these faculty, like the on-campus Extension faculty, be included with the apportion group that

is their academic home. After discussions with several Extension faculty and review of the past

actions that have resulted in the current organization, the Committee recommended

that the

Executive Committee study the issue through a series of focus groups within the special units to

gather the different perspectives and to engage the Senate in discussions.

3. Considered the recommendation submitted by Senator Cornell (CLA) to propose an amendment

to the Bylaws to ensure that when information is scheduled to be presented to the Senate, an

invitation is extended to those with opposing views on the subject so that information provided is

as balanced as possible. After review, the Committee felt that such an amendment was unnecessary

but did forward the suggestion to the Faculty Senate President and the Executive Committee, as our

elected representatives, for consideration as they determine the agenda for meetings.

4. Proposed revisions to the Faculty Senate Bylaws. The revisions included: identification of what

constitutes a vacancy in the Executive Committee, clarification of the substitutions for senators unable

to attend meetings, identification of what constitutes a vacancy for IFS Senators and a process for filling

any such vacancies, and clarification of nomination procedures for apportionment groups. The Faculty

Senate approved the revisions at its April meeting.

Suggestions for next year's committee:

 Consider ways to increase the percentage of faculty who vote in the election for

President-elect and IFS Representative

Consider use of email in the Senator election process

The Committee had a productive year. We have one recommendation for the Executive Committee in

its use of Committee Liaisons. It is recommended that Liaisons assure that committees are informed

of actions taken by the Executive Committee based on recommendations from the particular committee

(e.g., We referred the off-campus Extension issue but were not informed of any action taken).

In closing, we were encouraged by the willingness of the faculty to be considered for nomination to

Faculty Senate positions and offices. This willingness is clearly an indication that faculty governance

is valued and supported by faculty at OSU.

The following is a list of the activities of the Bylaws and Nominations Committee during the past year:

1. Nominated two candidates for Faculty Senate President-Elect, 12 candidates for the Faculty

Senate Executive Committee (to fill five positions), and two candidates for the Interinstitutional

Faculty Senate. Gordon Matzke was elected President-elect, and Gary Tiedeman was elected IFS

Representative. There was a 33% return of ballots in the President-elect and IFS Representative

elections. At the December meeting of the Faculty Senate, Bob Burton, Bill Lunch and Bruce

Sorte were elected to two-year terms and Stella Coakley and Dick Thies were elected to one-year

terms on the Executive Committee.

2. Working with IFS, presented to the Faculty Senate a process for nominating a faculty member to

the Oregon State Board of Higher Education. The Senate endorsed the process at its January

meeting.

3. Nominated three candidates to serve on the Oregon State Board of Higher Education to the

Nominating Committee of IFS. The nominees were Kelvin Koong, Clara Pratt, and

Gary Tiedeman,

and the OSU Faculty Senate endorsed the slate at its January meeting.

4. Proposed to the Committee on Committees a revision of the standing rules for the B&N Committee

to reflect its new role in nominating faculty to serve on the State Board of Higher Education. The

Faculty Senate approved the revised standing rules at its June meeting.

5. Proposed revisions to the Faculty Senate Bylaws. The revisions included: clarification of procedures

for voting privileges and eligibility to be a Senator, clarification of process for filling Senator and

President-elect, clarification of how the outcome of the election for President-elect is determined,

be included with the apportionment unit that is their academic home.


The Committee had a productive year. In closing, it was gratifying to find that many faculty were

Vacancies in elected positions shall be filled for the period to complete the term at the discretion of the Executive Committee by the candidate who, in descending order, received the next highest number of votes

in the most recent election.

However, if a vacancy results in an uncompleted term of less than one calendar year, the Executive Committee shall have the authority to appoint a faculty member of their choice to fulfill that term.
