# Research expenditures determine F&A



- Facilities and Administrative costs. AKA "overhead", "indirect cost recovery", "IDC"
  - Separate from "Returned overhead", which is what goes back to a unit.
- F&A costs = expenditures on research not attributable to a particular project
- *Our <u>expenditures</u> on research determine F&A rate:*

#### F&A Rate= Total F&A Costs Modified Total Direct Costs

#### F&A details



- Total F&A Costs = Total amount of the nine specific F&A cost pools assigned to organized, sponsored research
  - 4 Administrative pools (capped at 26%)
  - 5 Facilities pools
- Modified Total Direct Costs =

(Direct Salaries and Wages) plus (All Other Direct Costs)
minus (Equipment, renovations, off-campus bldg rental, tuition,
contracts > \$25k)

## OSU's F&A by the numbers

- OSU F&A rate = 47%
- FY16 F&A was \$39.8M
- total expenditures of \$217M
- MTDC = \$141.6M
- Note effective F&A rate = 28%, not 47%
- Foregone F&A (OSU research subsidy)  $\approx$  \$25M



#### OSU's F&A Rate



- F&A rate is set every 4 years, extendable to 5 or more
- Data for F&A rate come from the year before the F&A rate is set ("base year")
- Again, our <u>expenditures</u> on research determine the F&A rate
