The Committee consists of ten Faculty, eight Students, and a representative from Financial Aid, ex-officio, non-voting.

## Report

The Student Recognition and Awards Executive Team of the SRAC Committee (co-chairs and ex-officio member) met many times throughout the year to outline, organize and lay the groundwork for selecting and awarding the Waldo-Cummings Awards, Drucilla Shepard Smith Awards and AAUW Woman of the Year award. The Executive team also organized and implemented the awards ceremony for these awards as well as a number of other University Awards including:

The bulk of the committee work for the Student Recognition Committee is to review the many WALDO CUMMINGS applications submitted by students and to assist with the award event. Student Recognition committee members provided input on a variety of aspects of committee work related to actual applications for the Waldo-Cummings awards as well as the selection process for the WC awards. Committee member's main responsibilities are the review of applications, selection of interviewees for the awards, the selection of the awardees and honorable mentions, and assisting with the award presentations at the annual awards event. Committee members met with the executive team in February and March to help determine appropriate application materials and other event details.

In early April, an e-mail was sent to all GPA qualified students with a link to the on-line application for the Waldo Cummings award. As applications were received via the on-line form, each committee member began the screening process for their assigned class group. Awards and Honorable mentions are given at the Awards event to 12 first-year students, 12 sophomores, 20 juniors and 20 seniors.

The 'All University Student Awards Reception and Dessert' was held on Wednesday, May 21, 2008. Award winners, their families and many campus dignitaries were at the banquet including President and Mrs. Ray, Provost Randhawa and his spouse Uzma, Larry Roper, Luanne Lawrence, and many college Dean's or their designates as well as various faculty and staff. An E-mail/hold the date request was sent to the President, Provost, VPs, Deans, their administrative assistants, and other major stakeholders in early January to ensure that they had a block on their schedules for the event. Reminders were sent in late winter term and then a more formal invitation was sent a month before the event.

In the past there were several roadblocks encountered by the committee... **Summary of recommendations from 2007-08 Report:**

- The 2008-09 committee will be co-chaired – with the most recent past senior chair serving as an advisor to the incoming chair.
- The 2009-10 committee will be co-chaired – with the most recent past senior chair serving as an advisor to the incoming chair.
- Changes were made to the wording of the application to allow students to make better informed decisions about the application and what needs to be included on the application.
- Check box on the application was formed to let students know that confidential information, including GPA and hometown could be announced at the awards banquet.
- The on-line application format for the Waldo Cummings awards will be further refined.
- It is recommended that the University Advancement Office provide on-going funding to ensure that this event meets the needs of the university for the appropriate recognition of excellence in scholarship, service and student engagement. This is something that was started in 2008-09, but is in jeopardy because of the Financial Aid Office wanting more control of the event.

***To address concerns we implemented the following over the last two years and refined some strategies this year:***

1. Added the following **wording on the application** to help students make more informed choices about their class standing during the application process:  
“Advanced placement or college credit taken during high school should NOT be included to determine class standing for the purpose of this award application. If you are a 1st, 2nd. Or 3rd year student with greater than the number of credits listed in the class standing question, but will NOT graduate until your fourth year, you may still apply by your ‘year in school’ instead of the number of credits. If you feel there is a discrepancy between your ‘credit’ class standing and your year in school, select the ‘year in school category.’ For example, if you entered OSU with AP and/or junior college credits and are graduating in June but only have 90 OSU term credits you should apply as a senior. Note. Applicants may receive the Waldo-Cummings award only ONCE per class standing category.

Tip Ryan, the SRAC Ex-Officio Liaison, provided invaluable assistance in the process by providing class committees with details necessary to inform their work regarding the appropriate class group for a student

While we still had a few snags, overall the process for interpreting class standing eligibility for the awards seems to have been a success.

2. Last year (2006-07) we **implemented an ‘on-line’ application process.**  
The ‘on-line’ form was developed by Chris White, UHDS. Chris is prepared to host this form into the future and is ready to make any changes needed that the committee requires. He has indicated that it is not something he can ‘transfer’ to faculty senate – but that it would be easy to replicate using a simple on-line forms tool through computing services. A prototype of the application is included as an addendum to this report.

**Recommendation for next year** – we need to make changes to the application – specifically we need to add a statement regarding the release of information on the application. Because the awards ceremony is a public event, students need to be apprised that information which may be non-directory information will be announced at the event if they are in the award groups. We recommend that the following be added to the information section of the Waldo-Cummings Outstanding Student Award Application:

Applicants are advised that award details – including, but not limited to, cumulative GPA, major, academic department and other awards information may be announced at the Awards event and/or used in promotional materials. We also recommend having a check-box on the application if students do not wish to have information used or released.

3. Another area of improvement was **getting ASOSU to appoint students to the committee**. The Chairs and Ex-Officio began meeting in early October to strategize on this issue. We began the process of recruiting students in the fall term – and had a record number of student participants. Several of our student committee members were recruited by faculty/staff on the committee – which is a great model as long as we have a diversity of faculty/staff committee members. ASOSU was very involved and responsive this year to our needs for processing student applications for the committee.
4. We realized this year that our student members had access to a plethora of non-directory information as a result of their involvement on this committee. **We implemented an orientation for student committee members that included some training on FERPA and a confidentiality statement.** Included as [Appendix A](#) is a copy of the confidentiality statement used.
5. Another issue that arose in the past involved the **Drucilla Sheppard students attending the event**. We moved to a model this year of recognizing all the Drucilla Sheppard awardees – while it added a few minutes to the program we wanted to ensure that all students were publicly recognized for their academic achievement of a 4.0 for their academic career. We had nearly 250 RSVPs for the event – with approximately 230 in attendance. Several students were unable to attend due to mid-terms.
6. This year we provided **one complementary guest for each student for a faculty member, advisor or mentor to join them**. We also allowed students to bring two additional guests at a very nominal cost. This helped us have a much better turnout of faculty/advisors at the event. To help make it easier to **RSVP, students and guests were able to RSVP utilizing an on-line survey process using the BSG survey tool**. This provided committee chairs with up to the minute tracking of who had RSVP'd and guest names. Utilizing this RSVP method has streamlined the process for tracking who will be in attendance and has resulted in the elimination of the need for tickets at the event. One snag this year was check-in at the event – as we did not have enough tables to spread students and guests out to get them quickly through the check-in process.
7. Providing **name-tags to all students and guests** was another item that we refined this year – providing more possibilities for conversation among faculty and guests.
8. Due to feedback from Provost Sabah Randhawa and a few faculty last year, we **implemented a 'Reserved Table'** model for our special awardees and their faculty hosts/sponsors. This allowed us to have students seated with high ranking university officials – again providing more interaction for students with administrators and award sponsors.

Committee Co-chairs and the ex-officio member were in dialog on several occasions this year with the Faculty Senate President regarding event management and budget for the awards event. Some of our recommendations for the future include:

### Summary of Recommendations:

- Consider moving the event planning and management to University Advancement. This would allow the committee to concentrate on awards selection and award coordination.
- Continue with the on-Line application
- Continue to provide one complementary faculty/staff mentor guest for students and other guests at a nominal cost.
- Continue to work during Fall term to recruit student committee members and utilize an orientation and confidentiality agreement with student committee members.
- Continue to have a reception and dessert event.
- Continue to involve the Faculty Senate President as a narrator for the event and ASOSU and MUPC Presidents as the MCs.
- Meet with the Faculty Senate President, Financial Aid, University Advancement and Co-Chairs of Committee to determine who will be managing the event. The recommendation from the Co-Chairs is to use the expertise and financial backing of University Advancement to carry out the event, while allowing the ex-officio to market, make contacts and support application and data pull process to further enhance the event.

The Committee also plans and conducts, with the support of the ex-officio, an assembly or other appropriate program for the presentation of these awards to their recipients. The ex-officio works closely with the committee and is responsible for the tasks associated with the all-university recognition and awards program. The committee is responsible for selecting the recipients of the Drucilla Shepard Smith Scholastic Awards, the Clara H. Waldo and E.A. Cummings Outstanding Student Awards and the AAUW Senior Woman of the Year Award. The Committee consists of ten Faculty, eight Students, and a representative from Financial Aid, ex-officio, non-voting.

The Student Recognition and Awards Executive Team of the SRAC Committee (co-chairs and ex-officio member) met many times throughout the year to outline, organize and lay the groundwork for selecting and awarding the Waldo-Cummings Awards, Drucilla Shepard Smith Awards and AAUW Woman of the Year award. The Executive team also organized and implemented the awards ceremony for these awards as well as a number of other University Awards including:

The bulk of the committee work for the Student Recognition Committee is to review the many WALDO CUMMINGS applications submitted by students and to assist with the award event. Student Recognition committee members provided input on a variety of aspects of committee work related to actual applications for the Waldo-Cummings awards as well as the selection process for the WC awards. Committee member's main responsibilities are the review of applications, selection of interviewees for the awards, the selection of the awardees and honorable mentions, and assisting with the award presentations at the annual awards event. ***To address concerns we implemented the following over the last two years and refined some strategies this year:***

Or 3rd year student with greater than the number of credits listed in the class standing question, but will NOT graduate until your fourth year, you may still apply by your 'year in school' instead of the number of credits. For example, if you entered OSU with AP and/or junior college credits and are graduating in June but only have 90 OUS term credits you should apply as a senior. Note. The Student Recognition and Awards Committee (SRAC) met several times throughout the year to outline, organize and conduct the work of selecting and awarding the Waldo-Cummings Awards, Drucilla Shepard Smith Awards and AAUW Woman of the Year award. In addition, while not outlined in the committee charge, the SRAC also organizes and hosts the All-University Student Awards Event – typically held in late May. This event is a major portion of the work of the Committee Chair(s) and Ex-Officio member and should be included in the Charge for the Committee.

The All-University Student Recognition Awards Event honors the following award categories:

#### Waldo Cummings Awards

This year the Student Alumni Association awards were not given nor was the Charles E Wicks award since word was received from those who manage the awards selection that the two awards would not be offered this year.

The All University Student Award Banquet was held on Wednesday, 5/23/07 at the OSU CH2M HILL Alumni Center. Award winners, their families and many campus dignitaries were at the banquet including President Ray, Provost Randhawa, Larry Roper and many college Dean's or their designates. An initial invite was sent to all Campus dignitaries in early January to hold the date for this important event.

A few distinguishing highlights/accomplishments this year include the following:

1. In response to recommendations from last year's committee we implemented strategies to get more students to apply for the awards and then attend the awards banquet, how to lessen the paperwork of the class committee chairs and looking into another function to present the awards. This year the awards applications for WALDO CUMMINGS were available via a BSG web application. While this proved efficient for student access to the applications – yielding many more completed applications than in the past – the nature of the on-line data was very cumbersome for review by committee members, there were some significant problems with the information download, and we did not receive the quality of applications that we have in the past. The information received from applicants was barely adequate (and sometimes not adequate at all) to help differentiate between the students. We thought that there's a benefit in asking students to put a little more effort and energy into producing a solid application rather than just quickly filling out an online form. We thought that some kind of a compromise with something like the HR job application where students are asked to format a document and their resume and post them online, rather than filling out an online survey type of thing which seemed to make them think that relatively informal and kind of sloppy was ok. The committee recommends that we return to a paper process or to a process similar to the HR application format for the future. We saved many trees this year – but the team of faculty and student reviewers was unduly taxed in the process.
2. Record numbers of applications for the Waldo-Cummings Awards
3. Development of scoring rubrics for the applications
4. Ticketless event
5. Web-based RSVP process for the event
6. Implemented a dessert event with a reception per recommendations from last year's committee.

Through the course of conducting the work of the committee, several recommendations are being made regarding the work of the committee and the nature of the event that is organized by the Committee.

- While the 2005-06 committee made and accepted the recommendation that the SRAC Committee was to have Co-Chairs - due to the departure of one of the co-chairs the committee was again chaired by just one individual. [The hope for 2007-08 is that the committee will be co-chaired – with the most recent past senior chair serving as an advisor to the incoming chair.](#) This will provide more continuity and a share in the workload.
- As in past years, this committee continued to struggle with the assignment of student members. Due to the committee assignment structure, students are required to go through the ASOSU committee application process. [The SRAC committee recommends that this practice be suspended and that student members be assigned to the committee after application to Faculty committee members.](#)
- Further recommendations for the future from members of the committee are in regards determination of "class" for student award applicants. In years past, if a student applied and said they were a sophomore but they only had one term of credits at OSU and other credits were AP and/or Junior College credits, then their application was bumped back to the freshman class. The chair and/or the ex-officio member of the committee (who has access to Banner data) determined this and moved students around accordingly. We were told that this was done because, in order to be eligible to apply for the Waldo Cummings Award, students had to earn the 3.5 GPA at OSU, so only OSU credit hours should be considered. We again worked as a team (the Chair and the Ex-Officio Liaison) to make appropriate determinations of class standing for applications this year. This continued to be a very messy situation – and mistakes were again made. [For next year, we will work with the committee at an early meeting to interpret the award criteria more clearly so that we know exactly how to determine which class students really belong in. We will develop more clear written guidelines with the committee to aid in this work.](#)
- Faculty Committee members recognized that student members of the committee need additional structure and direction for their involvement in the work of the Committee. [As such, it is recommended that a basic outline of the responsibilities for student members be developed.](#)
- As a result of the dessert reception, the Committee received feedback from Faculty/Staff at the MU who felt that the dessert was not a worthy recognition for the outstanding students who were receiving awards during the event. The suggestion was made to move the event back to the MU and to move back to a more formal dinner event. [It is recommended that the MU have a perpetual seat on the SRAC – to provide historical perspective and knowledge and assistance with funding for the event.](#) The

event has been scheduled for May 21, 2008 at the MU – start time 6:00 p.m.

- Because the All-University Student Awards event is organized by the SRAC committee the recommendation is that the Provost and/or President’s Office provide on-going funding to ensure that this event meets the needs of the university for the appropriate recognition of excellence in scholarship, service and student engagement.

The Student Recognition and Awards Committee (SRAC) met several times throughout the year to outline, organize and conduct the work of selecting and awarding the Waldo-Cummings Awards, Drucilla Shepard Smith Awards and AAUW Woman of the Year award. These awards were presented at the All University Student Award Banquet on Wednesday, 5/24/06. Award winners, their families and many campus dignitaries were at the banquet including President and Mrs. Ray, Provost Randhawa and his spouse Uzma, Larry Roper and many college Dean's or their designates.

Through the course of conducting the work of the committee, one standing rules change was proposed and accepted. Rather than 8 faculty members, the SRAC committee will now be made up of 10 faculty members. This is due to the large volume of work for the chair.

Another recommendation accepted this year by the Faculty Senate Executive Committee was to have Co-Chairs on the committee. The senior chair would then mentor another person who would become the chair

the following year. This would provide more continuity and a share in the workload.

Other recommendations for the future from members of the committee are in regards to recruiting student members and figuring out which “class” student applicants actually belong to. It would be very helpful to receive more help from ASOSU in recruiting and appointing students to the committee. We were very fortunate to have several students involved, but these came from the faculty members of the committee recruiting them.

Another issue is how to determine which class students belong to when they apply for awards. In years past, if a student applied and said they were a sophomore, but they only had one term of credits at OSU and other credits were AP and/or Junior College credits, then their application was bumped back to the freshman class. The chair of the committee determined this and moved students around accordingly. I was told that this was done because in order to be eligible to apply for the Waldo Cummings Award, students had to earn the 3.5 GPA at OSU, so only OSU credit hours should be considered.

I worked with Ben Fisher, the SRAC Liaison, and with his research assistance to make these determinations this year for the committee. I have to say, it was a messy process and mistakes were made. For example, one woman who had enough total credit hours to graduate in June was moved back to the Junior class since she had only enough OSU credits to be considered a Junior. So, she withdrew her application for the award because she didn’t want to receive it as a Junior, she wanted to be considered as a Senior. This sort of messiness happened several times. For next year, I recommend that the committee work to interpret the award criteria more clearly so that we know exactly how to determine which class students really belong in. It is a chore to say the least, and there is no written guideline to aid the work.

Other issues recommended for next year’s committee to consider are strategies to get more students to apply for the awards and then attend the awards banquet, how to lessen the paperwork of the class committee chairs and looking into another function to present the awards. The idea of a dessert social has been suggested for the committee next year to look into.

Summary of recommendations:

- 1. Formalize process for determining which class students belong in after receiving WC applications
- 2. More effective recruitment by ASOSU to appoint student members to committee
- 3. Determine and implement strategies to recruit more student members to the committee
- 4. Determine and implement strategies to increase student attendance at banquet
- 5. Streamline paperwork for class chairs to lessen the load
- 6. Brainstorm other celebratory functions possible for award presentation (ex: dessert social instead of banquet)

In July 2002, Mary Ann Matzke and I met for a debriefing of her year as Chair of the SRAC and the All-University Awards Banquet. Bruce Sorte, President-Elect, Faculty Senate met with me during the fall to discuss the responsibilities of the committee and also to examine the Standing Rules. Bruce wants to come and talk to the committee when they convene.

#### January

The first meeting of the SRAC was held on January 31, 2003 in the College of Liberal Arts Conference Room in Gilkey Hall. At that meeting, we reviewed the tasks and timetable for the committee. This initial meeting also served as a time of introduction as the committee welcomed five new faculty and all new students to the process. Issues for discussions included the budget, questions from new members and the Standing Rules.

Budget figured prominently as the State of Oregon is experiencing difficult financial times. As the Chair, I informed the committee that I would be looking for ways to trim the budget as much as possible, without losing the quality of the awards and the banquet.

New committee members asked questions about their responsibilities. It was decided that subcommittees would be formed at the February meeting. Since there are three returning members they will serve as sub-committee Chairs in order to give the new committee members a year to go through the process. Unfortunately, the committee will have to have one new committee member step forward and offer their

services as a sub-committee Chair.

The final topic of conversation regards the Standing Rules. Every five years the Committee on Committees asks each committee to review their standing rules and verify that they are still accurate. We will be asked to do this and discuss it with a member of the Committee on Committees as well as with Bruce Sorte, President of the Faculty Senate. Bruce asked that we ask ourselves three questions: Why do we do this? Who is being screened out? Why are they being screened out? The committee will review the Standing Rules at the next meeting.

The All-University Awards Banquet was scheduled for May 28, 2003 in the CH2M HILL Alumni Ballroom. All committee members were asked to be present.

## **February**

The next meeting was held on February 20. At this meeting we decided sub-committee groups. They are:

Chairs of the Sophomore, Junior and Senior sub-committees served last year. Clay Torset stepped forward and volunteered to take on the Freshmen subcommittee.

The application packets were reviewed and final changes made to them. At this time I informed the committee that we would send out the letters via student onid accounts for the first time. This was an opportunity for the committee to save money. There was some concern about students who have not forwarded their onid accounts to their personal email accounts. Discussion ensued, but the final decision was that we would try it for one year and then review the process next year. While it is possible that some students may not have forwarded their accounts, their onid accounts are their official university accounts and the way for university officials to contact them.

Awards were also discussed. In the past few years we have given pens with students' names engraved on them. Students who have been multiple year recipients of Waldo Cummings now have several pens. Laurie Franklin informed the committee that she has a friend that will make us plaques with the OSU logo and the students' names engraved. As the plaques cost less money than the pens, and they will be nice awards, the committee decided to order the plaques for this year.

Bruce Sorte came to the meeting and spoke with the committee about the current Standing Rules and whether we felt it was accurate. The Standing Rules are:

*"The Student Recognition and Awards Committee conducts such investigations as may be necessary to determine student beneficiaries of the various Institutional recognitions and awards that are all-University in character. It also plans and conducts, with the support of the ex-officio an assembly or other appropriate program for the presentation of these awards to their recipients. The ex-officio works closely with the committee and is responsible for the tasks associated with the all-University recognition and awards program. The Committee serves as the Institutional registry for all recognitions and awards within the University; all recognitions that are listed in official publications, or the recipients of which are listed in official publications, are registered with the Committee. The Committee consists of eight Faculty, eight Students and a representative from Financial Aid, ex-officio, non-voting."*

After discussion, the committee came to the conclusion that the current Standing Rules do not reflect what the committee does and that they need to be altered. Committee members were asked to submit their thoughts and changes to the chair for discussion at the March meeting.

Budget was again discussed at the meeting. Emailing of letters and awarding plaques rather than pens will save money. The cost of the floral centerpieces was also discussed and it was decided that we would look for less costly centerpieces, without taking away from the celebratory nature of the recognition dinner.

The final discussion for February was about the AAUW Senior Woman of the Year Award and who buys the crystal vase for that gift. After the meeting Laurie Franklin and Mary Ann Matzke were able to track down the history of the award and the information was shared with committee members. OSU is a corporate member of AAUW, and Dr. Leslie Davis Burns decided several years ago that a certificate was not enough of an award for the Senior Woman of the Year. At the time, she was the Director of Undergraduate Programs and was the

corporate representative of AAUW at OSU. Dr. Burns started giving the gift as a contribution. The gifts are not expensive. AAUW is now under DPD, which is under Academic Programs, so Dr. Robert Burton is making sure that the award is still being given out.

## March

The next meeting of SRAC was held on Thursday, March 13, 2003 in room 208, Gilkey Hall.

Bruce Sorte, Faculty President, came to the meeting and we presented our proposed new Standing Rules. They are:

*"The Student Recognition and Awards Committee coordinates awards that are all-University in nature and that are awarded by faculty to students. The committee also plans and conducts, with the support of the ex-officio, an assembly or other appropriate program for the presentation of these awards to their recipients. The ex-officio works closely with the committee and is responsible for the tasks associated with the all-University recognition and awards program. The committee is responsible for selecting the recipients of the Drucilla Shepard Smith Scholastic Awards, the Clara H. Waldo and E.A. Cummings Outstanding Student Awards, and the AAUW Senior Woman Recognition Award. The committee consists of eight faculty, eight students and a representative from Financial Aid, ex-officio, non-voting."*

The committee will submit the above to the Faculty Senate to change the current Standing Rules to reflect the actual nature of the work the committee is doing. The committee felt that it is important to keep this committee as it holds a unique position in that faculty select the student recipients.

Bruce asked SRAC to consider reviewing the awards in the fall and ask the following questions:

- How are the awards addressing the university mission?
- What awards are we not doing?
- Do we want to add any awards?
- What awards do we need?
- What awards do we have?

The committee will review the above questions in the fall.

The committee also discussed ways to change the banquet and the awards in the future to give students more opportunity to show what they are learning. Areas covered included:

- Student presentation at the banquet.
- Poster session at the banquet, where all students would be invited to bring a poster to share. These will be placed around the perimeter of the room.
- Student presentations throughout the academic year.
- Seniors and juniors mentoring freshmen and sophomores.

The committee is interested in making changes and will discuss this at the beginning of the next academic year.

After the meeting, I meet with Kerry Kincannon from the Committee on Committees March 14, 2003 to discuss our committee review. Five Criteria, established by the Faculty Senate are reviewed. They are:

1. Do the Standing Rules clearly reflect the function and composition of this committee? **No**
2. Have the Committee's actions/functions, as reported in the annual reports and by consulting with the current Chair and Committee, been consistent with their Standing Rules? **No, please see above response.**
3. Do the annual reports provide a memory of the issues this Committee addressed, their activities, and any outcomes? **Yes**
4. What has been the role/benefit of student members? **Students are equal members on the committee. They receive committee experience, planning, decision making, learn to work as a team, develop organizational skills, understand the rules/regulations and policies governing a committee and attend the banquet.**
5. What connection is there to the University's strategic goals? **In relation to the 2007 SRAC supports the compelling learning experience for students. They are recognized and awarded for their**

**engagement in the learning experience. By supporting and acknowledging the academic success of our students we not only recognize but foster academic excellence in our students.**

Kerry and I discussed the changes to our current Standing Rules and he was informed that they would be submitted to the Faculty Senate.

Laurie Franklin contacted Mailing Services to inform them that we would not be using them this year due to sending out the letters via email. Laurie and I met with Edie in computing to talk over the sending of the files.

Students with a 4.0 cumulative grade point average are automatically awarded the Drucilla Shepard Smith. Students with a 3.5 cumulative grade point average at the end of winter term will be sent out the letter inviting them to apply for the Waldo Cummings Outstanding Student Award. The file was sent out at the end of spring break, on March 28th. 2360 letters were sent via email requesting students to apply. Students whose email bounced back received a letter via the post office. There were approximately 20 letters that were sent via regular mail. Of all the letters sent via email or regular mail, we received only one complaint from a student that did not receive the information. In talking with the student, she had chosen not to forward her onid account to her current email account, and also chose not to check her onid account. I explained that the university considers the onid account to be the one we will use for official university business unless a student forwards it to another account. This student opted not to forward and not to check their onid.

## **April**

The SRAC met on Friday, April 11, 2003 in room 208, Gilkey Hall.

The committee was updated on the email application process. We discussed study abroad students and how to handle any that were selected for interviews. It was decided that study abroad students selected for interviews will have their interviews conducted via email.

A question arose as to what to do with a student that graduated at the end of winter term. Should they be allowed to apply? In reviewing the application it refers only to seniors that have at least 135 credits. The committee felt that the implication was for the awards to go to students still enrolled at OSU and not graduates. The decision was to deny the request, and to make sure that it is fully explained in next year's application process.

Application deadline is Tuesday, April 15 with pick up of applications by committee members on Wednesday, April 16.

At this point, the committee broke into subcommittees to arrange times for submitting scores and scheduling of interviews. Committee members were asked to conduct interviews the week of May 5-9 and to have the results, including biographies to Laurie Franklin as soon after as possible.

## **May**

Individual subcommittees met and interviewed students. Decisions were made and the awardees selected. The recipients and honorable mentions were given to Laurie Franklin along with mini-biographies on each student.

Charlotte Headrick, Theater, College of Liberal Arts graciously agreed to be the narrator for the banquet.

Comp tickets - We ran into a problem this year with more people requesting complimentary tickets to the banquet than usual. The committee met all requests this year, but we will discuss next year prior to the start of the process how many tickets each organization will receive gratis.

The All-University Recognition and Awards Banquet was held on Wednesday, May 28, 2003 at 6:00p.m., at the Alumni Ballroom of CH2M HILL Alumni Center. Honored guests included OSU President Tim White along with the granddaughter and great-grandson of Clara Waldo. The event was sold out.

## **June**

The final meeting of the academic year was on Thursday, June 19, 2003 in room 208, Gilkey Hall.

The committee discussed the banquet and possible changes for next year. We will continue to use onid accounts to send out the applications.

Jane Siebler, Honors College, has been put forward as the Chair for the 2003-04 academic year.

The All-University Student Recognition and Awards Banquet is scheduled for May 26, 2004 in the Alumni Ballroom, CH2M HILL.

In July 2001, Laurie Franklin and I met for debriefing of the SRAC & All-University Awards Banquet schedule.

The first meeting of the SRAC was held on February 4, 2002 in the Faculty Senate conference room. We reviewed the Waldo-Cummings Award application and award letter as well as the timeline. We decided to ask for the name of an on-campus reference on the application. In the case of someone studying abroad, we will interview him or her by e-mail and contact the on-campus reference, if needed. We changed the designations of the Waldo-Cummings Award to "Award Recipients" and "Honorable Mention" to clear up confusion resulting from the terms "Finalist" and "Awardee". The All-University Awards Banquet was scheduled for Wednesday, May 29, 2002.

The next meet was held March 11. At this meeting we finalized the application and broke up into subcommittees so that they could plan their interview process. A timeline was drawn up to direct the committee and the subcommittees in their tasks.

March - Laurie and I met with Edie Lee in Information Services about running the computer files for the Waldo-Cummings (W-C) and the Drucilla Shepard Smith (DSS) awards (to be done as soon as winter grades are posted). I sent the W-C Award application and letter to Printing and Mailing and arranged for the mailout. W-C application packets were mailed out at the end of Winter Term 2002 to 2,503 full-time undergraduates with an OSU GPA of 3.5 or greater and completion of 24 graded OSU credits by the end of Winter Term 2002.



Applications were also solicited via the Daily Barometer. Mary Ann sent electronic versions of the application and letter to Gigi Bruce for distribution to faculty and adviser lists.

The Drucilla Shepard Smith Award was given to 43 freshmen, 29 sophomores, 23 juniors and 23 seniors who were enrolled in a minimum of 6 credits winter term and who completed at least 24 graded credits at OSU with a cumulative OSU GPA of 4.0. Laurie received the DSS file and mailed out the certificates and award letters over Mary Ann's signature.

April 24 - W-C application deadline in Student Involvement Office. Approximately 160 applications were submitted. Jean Duffy collected the student applications and sorted them into class categories.

April 25-May 3 - The subcommittees read files and selected students to interview. The senior and junior subcommittee each selected 20 finalists and the sophomore and freshman subcommittee each selected 12 finalists.

May 6-10 - The senior and junior subcommittees each interviewed 20 finalists, of whom 10 from each class were selected as Waldo-Cummings awardees and 10 were selected as honorable mention. The sophomore and freshman subcommittees each interviewed 12 finalists, selecting 6 each as awardees and 6 as honorable mention.

May 10 - Subcommittee chairs submitted biographical information on award recipients and honorable mentions to SRAC chair and Laurie Franklin.

April/May - Laurie Franklin contacted representatives of organizations sponsoring awards at the Awards Banquet, finalized award recipients and program presenters, and arranged for printing of the program. Laurie also made arrangements for catering and decorating. She got Leslie Burns to MC the program and wrote the program script.

May - Laurie prepared certificates for the Waldo-Cummings Awards. President Risser and I signed these. I arranged for the gifts (an engraved pen from Rayko) which were given to the W-C awardees. Jean Duffy handled ticket sales for the banquet.

The total income of the SRAC was \$6,550.65 and the total expense was \$6,861.93.

Note: We did not need a \$2,000 contribution from the Vice-Provost for Student Affairs this year. Laurie contacted Larry Roper and explained that we did not need the contribution this year, but hoped that he would continue his contribution if we needed it next year.

The next annual Award Banquet will be held on Wednesday, May 28, 2003 in the CH2M Hill Alumni Center. The date has been put on the President's calendar.

On June 11, 2002, the committee held its final meeting and made the following recommendations:

W-C Application: There was some confusion as to class level vs. year in school. We need a clear way to distinguish which group they are in (freshman, sophomore, etc.)

Essay questions - need work. Students expressed the desire for more open-ended, creative questions. The questions should emphasize what the student has done at OSU and in the community within the past year. Ask that students submit only college activities - not high school.

**Recommendation:** The committee needs to revise the essay questions and work out a clearer way to

distinguish class standing for the purposes of this award.

Mailing: The Drucilla Shepard Smith (4.0) award letters have gone out right after the computer run, but some students forgot to RSVP. **Recommendation:** Send the letters out closer to the RSVP date for the banquet. Include a tear-off RSVP portion or card to return.

Time-Line: **Recommendation:** Move the deadline for the W-C applications to April 15. Students said they did not need that long to complete the application and this would give the committee more time to read and interview the applicants.

Banquet: Problem with RSVP. Make it clear to students that their names will not be read for the Drucilla Shepard Smith award if they do not RSVP. **Recommendation:** The ASOSU and MUPC awards should not be given at this banquet next year. There is Student Involvement awards ceremony, which is more appropriate for this.

Invitations: **Recommendation:** Make an effort to invite the Clara Waldo descendents to the banquet next year.

Gifts: **Recommendation:** Select a different gift for next year. We have given the pens for several years and some students have collected more than one. Committee chair should look into this well in advance as the gifts are always ordered at the last minute and we have to pay extra for rush.

### Committee Charges:

1 & 2) Finalize policy on Drucilla Shepard Smith Award with regard to dual and concurrent enrollment.

We decided that we would not consider any transfer grades for the purpose of the DSS award. All OSU awards (honor roll, etc.) are based only on OSU GPA. Therefore, the DSS Award will be based on maintaining a 4.0 GPA in at least 24 graded OSU credits and enrolled in a minimum of 6 OSU credits Winter Term.

3) Look at changing language for W-C Awards from finalist to honorable mention.

We did this and felt that it was a big improvement.

4) Change Standing Rules to reflect that ex-officio is from the proper unit.

The ex-officio is correct. The Coordinator, University Scholars Program, is the ex-officio to this committee. That position is in the Office of Financial Aid.

**Recommendation:** the Standing Rules need to be revised. This committee does not determine all the awards given at the University Awards Banquet and does not serve as the institutional registry for all recognitions and awards within the university, etc.

5) Develop web page for W-C and DSS Awards. Check with Laurie Franklin regarding other university awards on the web page.

The committee did not think it would be useful to post information about the W-C and DSS Awards on the web. The DSS is given automatically based on GPA. Students are invited to apply for the W-C award and the criteria are listed in the application.

On November 8, 2000, Laurie Franklin and I met with Debbie Bird for debriefing of the Student Recognition and Awards & All-University Awards Banquet schedule.

The first meeting of the Student Recognition and Awards Committee was held on February 20, 2001, to initiate plans for selecting the Waldo-Cummings Award recipients and coordinating the All-University Awards Banquet scheduled for Wednesday May 30, 2001.

By April 19th, class sub-committees were established. A timetable was drawn up to direct the committee as a whole and the sub-committees in their tasks.

1. The Waldo-Cummings Award application forms were revised and distributed at the end of Winter Term 2001 to 2,360 OSU undergraduates maintaining an 3.50 GPA or greater after a minimum of 24 credit hours as of the end of Winter Term 2001. Applications were also solicited via the [Daily Barometer](#).
2. Eligible students subsequently submitted approximately 166 applications. Approximately 30 were returned, due to incorrect address.
3. 63 first-year students, 26 sophomores, 29 juniors, and 8 seniors who maintained a 4.0 GPA after a minimum of 24 credit hours were awarded the Drucilla Shepard Smith Award.
4. The senior and junior sub-committees each selected and interviewed 20 finalists, of whom 10 from each class were selected to receive the Waldo-Cummings Award. The sophomore and freshman sub-committees each selected and

interviewed 12 finalists, of whom 6 from each class were selected to receive the Waldo-Cummings Award. Interviews were completed by May 14, 2001.

5. Representatives of organizations sponsoring awards at the Awards Banquet were initially contacted on February 15, 2001. Names of award recipients and presenters were finalized by May 16, 2001, to facilitate program printing.
6. Banquet arrangements with catering were finalized by May 28, 2001. The scripting of awards was finalized by May 26, 2001.
7. Laurie Franklin and Camille Mongelli from the Office of Financial Aid drew up the timetable for the committee, planned the banquet, appointed the Master of Ceremonies, prepared the certificates and contacted the individuals in charge of other awards. Urmila Mali arranged for the gifts. Jean Duffy of Student Involvement collected student's applications and distributed them to committee members and handled ticket sales for the banquet.
8. The total income of the Student Recognition and Awards Committee was \$5,701.00 and the total expense was \$6,930.76.

10. On June 5, 2001, the committee held its final meeting and it resulted in the following recommendations:
  1. Ticket sales for the Student Recognition and Awards Banquet will go through the Student Involvement.
  2. Waldo-Cummings and Drucilla Shepard Smith Award's tickets will be distributed through Office of Financial Aid.
  3. One complimentary ticket will be given to each student for meal although they may be qualified through more than one award.
  4. Letters that are given to the Waldo-Cummings finalist and the ones mailed to Drucilla Shepard Smith Awards will include a portion on the attendees not leaving the banquet early.
  5. Provide the Student Recognitions and Awards Committee with a written descriptions and requirements for each awards.
  6. Finalize policy on who receives the Drucilla Shepard Smith Award looking at:
    - Dual enrollments
    - Concurrent enrollment

1. The Waldo-Cummings Award application forms were revised and distributed at the end of Winter Term to 2,072 OSU undergraduates maintaining an OSU G.P.A. of at least 3.50 after a minimum of 24 credit hours as of the end of Winter Term 2000. Applications were also solicited via the Daily Barometer.
2. Approximately 185 applications were subsequently submitted by eligible students. Approximately 22 returns, due to incorrect address, were received.

3. 33 first-year students, 25 sophomores, 18 juniors, and 9 seniors who maintained a 4.0 G.P.A. after a minimum of 24 credit hours were awarded the Drucilla Shepard Smith Award.
4. The senior and junior subcommittees each selected and interviewed 20 finalists, of whom 10 from each class were chosen to receive the Waldo-Cummings Award. The sophomore and freshman subcommittees each selected and interviewed 12 finalists, of whom 6 from each class were chosen to receive the Waldo-Cummings Award. Interviews were completed by Friday, May 5, 2000.
5. Representatives of organizations sponsoring awards at the Awards Banquet were initially contacted on March 6, 2000. Names of award recipients and presenters were finalized by May 8, 2000, to facilitate program printing.
6. Banquet arrangements and scripting of awards were finalized at the final meeting of the full committee on May 8, 2000.
7. Debbie Bird, Coordinator of the University Scholars Program, drew up the timetable for the committee, planned the banquet, appointed the Master of Ceremonies, arranged for gifts and certificates, and contacted the individuals in charge of other awards. Jean Duffy of Student Involvement collected student applications and distributed them to committee members, and she handled ticket sales for the banquet.
8. The total income of the Student Recognition and Awards Committee was \$5,552.50; total expense was \$6,437.75.

The first meeting of the SR&A Committee was held on Thursday, January 21, 1999 to initiate plans for selecting the Waldo-Cummings Award recipients and coordinating the All-University Awards Banquet set for Wednesday, May 26, 1999. Class Subcommittees were established. A timetable was followed to direct the SR&A Committee and the respective subcommittees in their tasks.

1. Standing rules were changed to include the Coordinator of the University Scholarship program as a liaison.
2. The Waldo-Cummings Award application forms were revised and distributed at the end of Winter Term to 1868 OSU undergraduate maintaining an OSU GPA of at least 3.50 after a minimum of 24 credit hours at the end of Winter Term 1999. Approximately 250 applications were submitted by eligible students.
3. 30 Freshmen, 13 sophomores, 11 juniors and 10 seniors who maintained a 4.0 GPA after a minimum of 24 credit hours were awarded the Drucilla Shepard Smith Award.
4. Applications for the Waldo-Cummings Outstanding Student Awards were sent to all eligible students and were solicited via The Daily Barometer .
5. Representatives of the organizations which sponsored awards presented at the Awards Banquet were contacted in March 1996. Names of award recipients and presenters were secured to facilitate program printing.
6. Interviews of Waldo-Cummings award finalists were completed by May 10.
7. Banquet arrangements and scripts of awards were finalized at the final meeting of the full committee on May 12, 1996.
8. Six students were members of the committee.

9. This was the first time the committee had a liaison who was the Coordinator of the University Scholars

Program, Debbie Bird. Debbie planned the banquet, master of ceremonies, entertainment, arranged for gifts and certificates and contacted the individuals in charge of other awards. I see no way this committee could run without such a liaison. Valerie Wetzel of Student Involvement helped by collecting applications and passing out and selling tickets.

Funding for the banquet and awards was secured from:

- \* Office of the Vice Provost for Student Affairs - \$500
- \* Endowment Funds - \$2,400.00
- \* Beginning Balance in Awards Account \$2,930
- \* Ticket Sales \$1,215

Leaving a positive balance in the Awards fund to begin next year's program with. Last year, the Vice Provost for Student Affairs contributed \$4,379.74 (catering and facility). Depending on budget and funding in future years, Vice Provost's office may again be asked to provide additional funding. Partial funding is also built into the University Scholars Program budget by default of the liaison to the committee being the coordinator of the University Scholars Program.

It is recommended that the work of this committee to recognize student achievement through awards and the award banquet be continued in the 1999-00 academic year.




