DIRECT TRANSFER ARTICULATION AGREEMENT between SOUTHWESTERN OREGON COMMUNITY COLLEGE and OREGON STATE UNIVERSITY

Effective: Summer Term 2017 through Spring Term 2019

A.S. in Chemistry at Southwestern Oregon Community College to B.S. in Chemistry at Oregon State University

It is agreed that students transferring from Southwestern Oregon Community College, having completed their Associate of Science Direct Transfer (AS-DT) degree in the major listed above and having completed the courses listed in this agreement will be granted the course equivalencies in the Bachelor of Science in Chemistry at Oregon State University. Students will be granted junior standing. All of the lower division Baccalaureate Core course requirements (Skills and Perspectives), and all of the lower division courses required in the major/option will have been fulfilled

This agreement is based on an evaluation of the rigor and content of the degree requirements at Southwestern Oregon Community College and the Baccalaureate Core requirements at OSU along with the Bachelor of Science degree requirements in Chemistry.

This agreement is subject to yearly re-evaluation by both institutions for continuance. Changes to the degree requirements, or to courses at either institution will necessitate an addendum that will be attached to this articulation agreement.

Notes

- Students who hold an OSU approved direct transfer degree (e.g., AA-DT, AS-DT, AAOT), or who have 90 or more completed credit hours in transfer will be granted junior standing.
- Generally, no course can be used to meet more than one requirement. This requirement varies by college. (Contact the college head advisor.)
- College, schools, departments, and programs may restrict the courses used by their students to satisfy general education (Baccalaureate Core) requirements. (Contact the college head advisor.)
- Transfer credits and grades are not used in calculating the OSU cumulative GPA.
- OSU will accept D grades. However, some colleges, schools, departments, or programs may not accept D's in required courses. (Contact the college head advisor.)
- The deadline for Fall Term financial aid consideration is February 1st.
- Application for admission to OSU is on a rolling basis with the deadline one month prior to the start of the term.
- This articulation guide is subject to change without notice. Students should visit with their community college or OSU advisor if they have any questions.
- LDT: Lower Division Transfer; UDT: Upper Division Transfer; NAT: Not Accepted in Transfer
