Skills Courses, Writing III / Speech: I can't confirm that Southwestern Oregon offers SP 114. Is it new for 2017-18, and if so, should we have our department review the syllabus for OSU equivalency? The other course, SP 111 = COMM 111 at OSU is fine.

I removed SP 114 from the SWOCC column, as it is not taught at SWOCC

Perspectives Courses, Physical Science (with lab): BI 202 is not a physical science course.

I swapped BI 202 with PH 211... I moved BI 202 to "Major: Requirements" and moved PH 211 to the "Physical Science (with lab)"... is this correct?

Perspectives Courses, Social Processes and Institutions: The word "Social" is missing from "Choose from/any ... " columns.

I added the word "social"

Difference, Power, and Discrimination Course: This is a minor thing but DPD isn't an OSU Perspectives requirement, is it? It is so identified in the SWOCC column.

I removed the word "Perspectives" from the SWOCC column

Another minor thing: It states "Additional OSU Baccalaureate Core Requirements (Upper Division) (9)." This includes a 3-credit WIC but my understanding from Martin Main is that WIC is not a bacc core requirement but a major requirement.

I moved the WIC from "bacc core requirements" to "Major: Requirements"... is this correct?

Major Requirements: Southwestern Oregon's CHEM 245/246/247 will be counted as lower-division credits even though they transfer as equivalent to CH 331/337/332. Just want to make sure that is understood.
