Course Description

This internship experience provides students with basic personal and professional skills that can be used within and outside of a work setting. Through practice, this experience guides students in building and maintaining positive professional relationships, networking/mentoring relationships, and enhances students' understanding of the connection between theory and practice in their respective disciplines.

Student Learning Outcomes

By the end of a student's internship experience, they should have:

- Linked academic theories to practice in their discipline;
- Applied knowledge, skills, experience from the academic setting to the work environment;
- Acquired new knowledge or skills through challenging and meaningful activities;
- Reflected on the content and process of the internship experience;
- Advocated for their own learning in alignment with goals for the internship experience;
- Demonstrated satisfactory professional skills in the workplace;

- Built and/or maintained positive professional relationships;
- Demonstrated awareness of community and/or organizational issues related to goals for the internship experience;

Assessment of Student Learning

- Creation of a final project appropriate to the discipline that challenges students to achieve beyond their current ability levels by integrating and applying knowledge and skills from across the program of study. This project includes:
 - A detailed description of work activity;
 - O An evaluative analysis of the relationship between the work activity and the student's supporting coursework.
 - O Explicit suggestions for improving the internship experience.
