## **Course Description**

This non-credit undergraduate internship experience provides students with basic personal and professional skills that can be used within and outside of a work setting. Through practice, this experience guides students in building and maintaining positive professional relationships, networking/mentoring relationships, and enhances students' understanding of the connection between theory and practice in their respective disciplines.

### **Student Learning Outcomes**

- Link academic theories to practice in their discipline
- Apply knowledge, skills, and experience from the academic setting to the work environment
- Acquire new knowledge or skills through challenging and meaningful activities
- · Reflect on the content and process of the internship experience
- · Advocate for their own learning in alignment with the goals for the internship
- Demonstrate satisfactory professional skills in the workplace
- Build and/or maintain positive professional relationships
- Demonstrate awareness of community and/or organizational issues related to goals for the internship
- Identify, clarify and/or confirm professional direction connected to the academic endeavor and/or career path
- Develop self-understanding, self-discipline, maturity and confidence
- Develop strong networking/mentoring relationships

Assessment of Student Learning Students' non-credit course registration will result in the "SC-successful completion" mark on their transcript for a non-credit undergraduate internship experience after satisfying the following requirements:

- At least thirty (30) hours of student engagement in activities related to the planning and execution of the internship project (3 hours per week over 10 weeks)
- At least two (2) structured opportunities to reflect and self-assess and detail what students have learned at different stages through the process of completing their culminating project
- Creation of a culminating project report that challenges students to achieve beyond their current ability levels by integrating and applying knowledge and skills from across the program of study
- A satisfactory Site Supervisor Evaluation

Failure to complete these requirements will result in the "NSC- Non-successful completion" mark on their transcript.
