## Materials linked from the March 23, 2018 Curriculum Council agenda.

HB2998 mandates two major outcomes:

1) Recommend a foundational curriculum that is fully transferable from community colleges to universities that minimizes lost credit.
2) Determine the initial major disciplines for which unified statewide transfer agreements (USTAs) will be established. These agreements should allow community college transfer students to enroll in universities with junior standing in the major (although not necessarily the university).

A workgroup consisting of representatives from the universities and community colleges was convened by HECC to accomplish this.
There have been two previous attempts at a foundational curriculum: The AAOT and the OTM.

The FC curriculum is a subset of the AAOT ( 90 credits) and the OTM ( 45 credits), which OSU has already approved. The AAOT meets all of our lower-division Bacc Core requirements. The OTM is
supposed to meet Writing I, II, and III, Math, Literature and the Arts, Western Culture, Social Processes, and Bio/Phys Science.

The FC must not be a course-by-course articulation. It must be a block transfer. Community college courses that count towards the FC will meet the AAOT learning outcomes for the individual areas above, but may not articulate as specific OSU courses.

On the basis of the AAOT learning outcomes and their OTM articulation, it is proposed that the Foundational Curriculum is equivalent to 8 Bacc Core courses, fulfilling eight Bacc Core area requirements:

Writing I, Literature and the Arts, Western Culture, Social Processes, Cultural Diversity, Two of the three Science courses (which two will depend on which ones taken at CC), and Math.

*The AAOT and OTM do not list Cultural Literacy as a separate course, but rather as a characteristic or certification that other courses in the AAOT might have. It was not in the original OTM but was added when JBAC instituted Outcomes \& Criteria for AAOT \& OTM courses in 2007/8 (reviewed by our Bac Core Committee and approved by the OUS Provosts' Council).
**HB2998 requires 30 credits. If a student were to take the fewest possible credits in all areas, they would only total 27 credits.
