Instructor assesses participation in class discussion and in low- stakes critical thinking analysis and peer workshop and responses, guided investigations of writing strategies, exercises in self-reflection, and draft development in two case studies and three major writing assignments.
Analyze aspects of Western culture in relation to broader cultural, scientific, or social processes	Recognize how films (as a mass/popular commercial medium functions to reflect and refract social and cultural (everyday) life as well as a larger cultural/political history. Demonstrate the ability to compose a document of at least 2,000 words through multiple aspects of writing, including brainstorming, drafting, using sources appropriately, and revising comprehensively after receiving feedback.	The class will consider methods for selecting a research paper topic, how to complete elements of the paper, and the use of style sheets. Students consider the evolution of peer- review practices, engage in peer-review, and revise <i>complete drafts</i> of research papers.	Assessment (s): The research paper is graded on content, prose, grammar, and punctuation. The topic of the paper is generally the history of a single disease or health condition. It must demonstrate the student's research skills and compare and contrast selected historical aspects of health, disease, and healing.
