

OSU Faculty Senate News

February 9, 2022

The OSU Faculty Senate represents academic and research faculty (tenure, tenure-track and fixed-term), as well as professional faculty. There is no minimum FTE for Faculty Senate inclusion. The defined faculty ranks appear in Article III of the Bylaws at https://senate.oregonstate.edu/bylaws.

1. January Faculty Senate Action Items

- Motion to approve Michael Beachley as Faculty Senate Parliamentarian; motion passed with 65 votes in favor, 0 votes in opposition and 1 abstention.
- Motion to approve changes to the Food Science and Technology
 Undergraduate Major (BS, HBS) Key #185; motion passed with 73 votes in favor, 0 votes in opposition and 3 abstentions.

2. Student Bill of Rights

On December 9, 2021, students representing the ASOSU Office of Advocacy presented a request to the Faculty Senate to require the addition of the Student Bill of Rights on all course syllabi; Faculty Senators approved this request.

By including the Student Bill of Rights in course syllabi, students felt that it:

- Reinforces the concept of a syllabus acting as a written agreement between faculty and students
- Protects students and faculty
- Reminds faculty of their responsibility to follow their syllabus
- Improves course transparency and clarity
- Demonstrates OSU's commitment to student success

Please ensure that the entire Student Bill of Rights appears on all syllabi – linking is not acceptable.

3. **OSU Presidential Search Update**

Trustee Julie Manning, Presidential Search Advisory Committee (SAC) chair, will provide a brief update at the February 10 Faculty Senate meeting. There has been significant activity related to the search since Trustee Manning's update at the December Faculty Senate meeting. The SAC, with executive search firm Isaacson, Miller, held 15 listening sessions (including one with the Faculty Senate) and used an online survey to gather input from OSU community members and stakeholders. Over 200 people participated in the listening sessions, and over 140 responded to the survey, providing input regarding the

qualities and qualifications that the next president should possess, and the opportunities and challenges facing the university. This input helped to inform the creation of the <u>Presidential Profile</u>, a document that serves as both a recruiting and evaluative tool for the board and the SAC, which the Board of Trustees unanimously adopted on January 28. Nominations for president are welcome and should be submitted to <u>presidentialsearch@oregonstate.edu</u> as soon as possible to allow maximum time for consideration. On February 10, Julie will provide further information about community engagement and next steps in the search process.

4. Baccalaureate Core Reform

The Baccalaureate Core Reform Committee co-chairs, Dr. John Edwards and Dr. Lori Kayes, are hosting college forums. Participants will learn about the reform process, preview curricular template drafts, engage in conversation and provide feedback. Participation and collaboration will help inform the final curricular model proposed to the university for adoption. Please share this message broadly throughout your college. Individual college forums have been scheduled and invitations sent to college leadership with a registration link to attend. 6. Interim President Johnson to Meet with Faculty

Interim President Johnson and the Faculty Senate Executive Committee are continuing the long-standing tradition of sponsoring small group faculty conversations with academic, research and professional faculty. Each conversation will be facilitated by a Faculty Senate Executive Committee member and will consist of up to 12 faculty. These conversations, via Zoom, provide Interim President Johnson with an opportunity to receive candid feedback from faculty and an occasion for idea and information exchange.

7. University Accreditation Update

OSU is in the third year of our seven-year accreditation cycle, with the Mid-Cycle Evaluation Report due to the Northwest Commission on Colleges and Universities (NWCCU) in early March. This is followed by a virtual Site Visit by NWCCU peer evaluators Monday, April 25-Tuesday, April 26. The Mid-Cycle Review is intended to be a formative and collegial review with the evaluators assessing our progress in the areas of mission fulfillment, student achievement and assessment of student learning. The peer evaluators will request meetings with OSU faculty, staff, and students. In anticipation of the visit, please keep these days in mind for a possible meeting with the evaluators.
